About the Presenters



Madeline Bryer

After being victimized in her apartment by a criminal, Madeline Bryer sued her landlord and left her job as a psychiatric social worker to earn a law degree. She has been in private practice 20 years and has won many million dollar settlements and verdicts fighting for rape victims, victims of sexual assault, lead poisoned children and other victims of serious negligence. The fourth trial she ever litigated resulted in a \$1.5 million settlement and her victories have continued. She recently obtained the highest verdict upheld on appeal for a crime victim who was neither sexually assaulted nor maimed.



Jeffrey R. Dion

Jeff Dion has championed crime victims' rights for more than two decades. Jeff began advocating for victims in 1982, when his twenty-three year old sister, Paulette, was murdered by a serial killer. In honor of his sister's memory, Jeff lobbied the Virginia General Assembly, resulting in 13 victims' rights bills being enacted into law. In 1998, Jeff joined the staff of the National Center for Victims of Crime, where he currently serves as the Director of the National Crime Victim Bar Association.



Jason A. Frament

Mr. Frament practices primarily in the field of civil litigation, including personal injury, products liability, automobile accidents, medical malpractice, legal malpractice, premises liability and commercial litigation. He also focuses on real estate and criminal defense. Mr. Frament was elected and currently serves as Village Justice for the Village of Scotia. Mr. Frament is admitted to practice law in New York State as well as the United States District Court, Northern District of New York. He is a member of the Albany and Schenectady County Bar Associations as well as the New York State Bar Association. Mr. Frament is an active member in the New York State Trial Lawyer's Association and the New York State Magistrate's Association. Mr. Frament earned his J.D. from Albany Law School of Union University in 2000 where he was a Dean's List student. He graduated from the State University Of New York Institute of Technology in 1996.



Marc Hamilton

MARCI A. HAMILTON is one of the United States' leading church/state scholars and holds the Paul R. Verkuil Chair in Public Law at the Benjamin N. Cardozo School of Law, Yeshiva University. Professor Hamilton is also an author and lecturer on the protection of vulnerable children from institutions, and a national leader and advocate for legislative reform of statutes of limitation reform through her website, www.sol-reform.com. Professor Hamilton has been honored as one of Pennsylvania's Women of the Year; received the National Crime Victim Bar Association's Frank Carrington Champion of Civil Justice Award; the E. Nathaniel Gates Award for outstanding public advocacy and scholarship; and the Lifetime Achievement Award for Pro Bono Legal Service to veterans groups. She clerked for Supreme Court Justice Sandra Day O'Connor.



Cynthia S. LaFave

Cynthia has always been an advocate for those who have found their lives turned upside down because of injuries due to some other person or entity's negligence. She is passionate about her career and takes to heart the needs of her clients. She is an active and prominent local attorney. Cynthia graduated from Syracuse University College of Law, where was awarded the Best Direct Examiner. Cynthia has received many verdicts and settlements in excess of one million dollars for her clients. In 1996 she received the highest personal injury verdict for the entire United States, in the total sum of \$94,500,000.00. Past Vice President for the Third Judicial Department, NYS Academy of Trial Lawyers; Past Present of the Capital Region Affiliate of the NYS Trial Lawyer's Association; Past President of the Albany County Bar Association; a delegate to the NYS Bar Association; Member American Association for Justice; American Board of Trial Advocates; Capital Region Trial Lawyers Association.



Michael J. Reck
